#### **4.2 Earth Day Clean-Up at the Eco Park Follow-Up**

Jim Campbell shared event details. The event was delayed by one day due to weather, with an estimated attendance of 30 to 40 people. The committee discussed opportunities for future events such as an interactive activity for children, to encourage engagement with parents while the children participate.

#### **4.3 Proposed Climate Action Awards**

The committee discussed a proposed framework for recognizing climate action initiatives including nomination timeline, application process and various recognition opportunities.

Moved by Jim Campbell, Seconded by Owen Gray, Be It Resolved that the Climate Action Advisory Committee endorse the development of a Climate Action Awards program, and

That the staff liaison takes a report to Council for its consideration, outlining the proposed Climate Action Awards program, including objectives, eligibility criteria, and program structure. Motion Carried.

### **5. Two-Minute Fact Share**

- Councillor Beelen shared seasonal updates, noting that leeks, wild mushrooms, and soon wild asparagus emerge as the ground warms.
- Jerry raised concerns about battery storage at an old airport site and the need for fire department training to address potential infrastructure-related emergencies.
- Allison expressed a growing interest in birding, noting recent goldfinch sightings at a backyard feeder.
- Jim highlighted the upcoming Ramp Romp event and suggested that, instead of the usual two-minute fact share at the next meeting, members take time to reflect on their reasons for joining the committee and the goals they hope to achieve, to help align future initiatives.
- Owen discussed climate programs, emphasizing citizen involvement in evaluating strategies, the significant role of transportation emissions, and learning from other municipalities' engagement models.
