### **8.2 Support Resolution – Inclusion of Non-Plug In Vehicles in Canada ZEV Mandate**

##### **Resolution:**

Moved by Councillor Dineen, Seconded by Councillor Broderick, Be It Resolved that Council of the Township of Clearview recognizes that Honda Canada has been a longstanding partner and major employer to Simcoe County, including residents from

Clearview, employing approximately 4,200 people directly and supporting an estimated 30,000 indirect jobs; and,

With this recognition, Clearview Council supports the request from the Town of New Tecumseth to the Federal Government to revise the Zero-Emission Vehicle (ZEV) Mandate to include Non-Plug-In Hybrid Vehicles as fully eligible vehicles in an effort to support Honda and other Canadian auto manufacturers that are facing increasing challenges due to global market pressures, U.S. tariffs, and the exclusion of Non-Plug-In Hybrid Vehicles from Canada's ZEV Mandate; and,

That this support resolution be forwarded to the Association of Municipalities of Ontario, Simcoe County municipalities and Simcoe-Grey MP Terry Dowdall.

Deputy Mayor Van Staveren stated that the new NVCA President and CAO have done a great job at streamlining processes and speeding wait times up. Motion Carried.
