BUILDING PERMIT FEE BY-LAW REVISIONS NOTICE OF PUBLIC MEETING

TAKE NOTICE that the Council of the Corporation of the Township of Clearview will hold a public meeting on the 13th day of December 2021 at 6:30 p.m., to consider amending the Building Permit Fee By-law under Section 7 of the Building Code Act.

PURPOSE AND EFFECT:

The Township of Clearview is proposing to adopt (amend) the Building Permit Fee By-Law following a review of the building permit fees under Section 7(b) of the *Building Code Act*.

The effect will be to **not increase** the Building Permit fees by the annual indexing as set out in the by-law for the year 2022. No other changes to the existing fee by-law are proposed. Information will be provided at the meeting on the proposed revisions and the rationale for **not increasing** the building permit fees for the year 2022.

ANY PERSON may attend the public meeting via zoom and make written or verbal representation either in support of or in opposition to the proposed change.
