Budget Process

- The Senior Management Team began gathering information for the Operating and Capital budget in the early fall of 2023. Actual expenditures are compared to the budgeted expenditures and modifications are made based on the best estimates available for the 2024 budget.
- These proposed budgets were then presented to Council for consideration on November 8th and 15th.
- At the December 5th, 2023 meeting, Council then modified the staff proposed budgets resulting in the Council Proposed budget being presented today

Highlights

- Total Capital Budget
 - Infrastructure and new asset requirements
 - \$123.4 million (\$90.5 million in development charge related projects)
 - \$32.7 million in general capital & \$90.8 million water/wastewater
 - \$2.4 million in funding is from taxation
- Total Operating budget including service partner requisitions (County, OPP, NVCA, School Boards)
 - Funding for the day to day operations of the municipality
 - \$33.6 million total operating budget
 - \$19.8 million in funding from taxation




Clearview Tax Supported Services


- 249km of Roads, 73 bridges and culverts, 21km of sidewalks

Tax Dollar Breakdown




Where does the \$ come from
