



**Township of Clearview – Centre Line Road Reconstruction  
Construction Newsletter No.2  
(2026 Construction Update)**

Centre Line Road, between Sunnidale Concession Road 7 and Simcoe County Road 9, is anticipated to recommence construction on **May 25, 2026**, and will be completed this construction season.

The work generally consists of road reconstruction and pulverization in localized areas, roadside drainage improvements, extension of existing culverts, installation of new culverts, culvert clean-out, roadway grading, paving and restoration.

**Traffic Conditions and Public Access During Construction**

The road will be closed to through traffic during construction within the project limits. Only local residents and emergency vehicles will have access during construction.

A detour route will be designated and signed. It is advised that cyclists take alternative routes.

The Contractor will provide traffic management and signage to ensure the safety of the public.

**Will there be Access to My Residence or Business?**

Where work is located within driveways or entrances, access will be restored at the end of each working day. The Contractor will give prior notice of any vehicular access restrictions. We ask for your patience in such instances.

**How Will My Services Be Affected?**

Any interruptions to telephone, electrical, gas and other utilities and services are not anticipated.

The Contractor will ensure that regular garbage and recycling collection will be maintained during construction activities. However, it may be necessary for the Contractor to collect the garbage and recycling containers and take them to a designated area to be collected. The Contractor will return the containers to individual properties on each garbage day. Please be sure to clearly label your containers with your address so that they can be returned.

**Special Access Needs**

If you require special access to your property during construction, please contact the Contractor’s Site Supervisor or R.J. Burnside & Associates Limited’s Site Inspector.

**Safety**

The Contractor is required to conduct the work in a safe manner, including fencing of the work area, etc. We ask that you take extra caution during the construction period to ensure everyone’s safety.
