#### 8. New Business

M. Boyd's Policy Review Report has been deferred to the February 20, 2024 Clearview Public Library Board meeting.

The CEO advised that the latest communication from the Ministry of Tourism, Culture and Sport notes that the Board's Provincial Library Operating Grant and Pay Equity Grant will not be transferred to the Board until the Ministry receives the audited financial statement for 2022. The CEO advised that this document has not been received by the municipality to date, and she is therefore unable to provide it at this time. The CEO also requested that exceptions be made for the Ontario public libraries that are currently awaiting receipt of their audits.

L. LaFleshe noted that cyber security has become an important issue for public libraries. Toronto Public Library and London Public Library are two Ontario systems that have had cyber attacks recently. She inquired what steps Clearview Public Library has taken to reduce the likelihood of this occurring. The CEO responded that staff have to use two step authentication both to log into their staff email accounts, and to log into a staff computer. Regular cyber security training is provided by the Township of Clearview IT Coordinator to all Township staff, including Library staff. It is mandatory.

- L. LaFleshe inquired whether Clearview Public Library can ensure that public access computers delete all data collected after each session. The CEO will contact the Simcoe County IT Department to ascertain how this can best be achieved.
- D. Measures noted that it would be advisable to have an external audit of the Library's cyber security. The CEO advised that she will contact both the Township IT Coordinator and the Simcoe County IT Department in this regard.
- L. LaFleshe noted that she has heard from a number of people who find the online registration for programs difficult to use. J. Ross concurred. The CEO will look into this situation.
- D. Measures noted that the 95.1 Peak FM radio station interviewed the CEO of the Collingwood Public Library about their new website. He noted that Clearview Public Library's website appears dated in comparison. The CEO advised that the Library's website was redesigned as a group project with 10 other public libraries. If another redesign is to take place all 10 would have to agree, or Clearview Public Library would have to have a brand new website designed specifically for it. The CEO will ask the Chair of the County CEOs' Committee to add website redesign to the next meeting agenda.
