- Zoning By-law Amendment Application
- Draft Plan Subdivision/Condominium Application
- Site Plan Approval Application

Based on the information provided in this form, Planning Staff will provide you with a Pre-Consultation Response that will outline those items (plans and studies) that are required to initiate a formal application. Any comments produced by the Township or consulting agencies as a result of the information provided in this form are preliminary and are not to be taken as an opinion of Planning Staff or a decision of any kind. Participating in the pre-consultation process does not authorize the initiation of any construction or preparatory work on site, including the clearing of trees or vegetation or any site alteration.

Along with this completed form, all submissions must include two (2) hard copy drawings (at least 11"x17") and a digital (PDF) copy of concept plans. Other supporting materials (i.e., plans and studies) are beneficial. Plans must show in metric the following:

- Dimension of property (frontage/area) and delineation of lot lines
- Location of existing and proposed buildings/structures
- Setbacks from existing and proposed buildings/structures to adjacent lot lines, wells, septic systems, and other buildings/structures on the property
- Location and setbacks from any features on the property including natural features (stream courses, slopes, wetlands, forests), roads, utilities, and agricultural facilities
- Size and height of existing and proposed buildings/structures
