

Hi Cayla, I can not make the meeting tomorrow, Sept 30th. For my Treasurer report, our current bank balance is \$27,447.62.

Cayla, can you please add to the agenda and advise board members that the TD bank will no longer deposit cheques made payable to The Duntroon Hall. All cheques must be payable to Corporation of the Township of Clearview. TD will also accept Nottawasaga Community Hall, but I am not stating that as we changed to The Duntroon Hall to avoid confusion with Nottawa, so there is no point going back to that. If I did not include you, I will forward an email from Kelly McDonald on this subject. Perhaps etransfers will be available to us in the near future.

The minutes of the May 28, 2019 meeting, item 9.1, state: *Moved by Suzanne Wesetvik, seconded by David Culham, Be it Resolved that The Duntroon Hall adopt "The Duntroon Hall" as the official name. Motion Carried.* We now need someone (not me) to take on this project and work with the Township to officially change the name. We adopted The Duntroon Hall as our name years ago and although this motion was carried in May this year it does not make it official. Now with the problem with the TD we need to move forward on this. There will probably be legal costs involved, and we now have the money to proceed with this.
