This email is being sent to you in regards to "amendment-zoning-law-06-54-august-23rd, Cannabis in Clearview Township". Our address is 6992 Nott. 27/28 Side Road, RR#4, Stayner, Ontario, L0M 1S0. Our names are Carl and Kitty Wagner. We have lived at this address since 1981. I (Carl) was born in 1940 and lived in the area until 1958, moved to Toronto and returned to this area in 1981. Our families settled here in the 1840's and have continued to live here ever since.

Kitty and I have been involved in a couple of costly issues namely Pig Barns and Wind Turbines. We have worked with the township and local concerned families to make sure reasonable set backs were in place and in the case of the Turbines the removal of the project completely. This has cost us personally tens of thousands of dollars.

We need proper setbacks, building requirements, business licenses and protection from devaluation of property. One only needs to look at the property located on the 6th line Fire #1826 to see what can happen. I am sure the township approved the installation of these green houses when the family applied for a permit to build them. We know how that worked out. A high unpainted plywood fencing was added to the front of the property which added another element of concern. Kitty and I have felt the pain

and worry of our home and property being devalued by 50% due to the potential installation of wind turbines in our back yard. We believe without proper setbacks the smell of cannabis will also greatly devalue our property. This is not a smell that will go away after a rain. We hear people say "well you live in the country. What do you expect?" we expect proper setbacks.

We have a great township that we are proud of. The corner of the 6h line and 27/28 side road is a good example of when neighbours work together farming, raising families and working from home and retirement. Rumor has it that this corner is one of the best kept corners in all of Clearview. Our township is a big place with lots of open areas.

We trust you will look after our concerns. Working together is always better.
