I am sure that you are receiving quite a bit of community feedback regarding proposed Cannabis by-laws. Please add my comments to the mix.

I hope the Counsel recognizes that Clearview has managed to catch "lightening in a bottle". The Clearview area includes the incredible rare and desirable combination of natural beauty, access to the bay, mountains and proximity to the Toronto population mass. This is what make the area so desirable, has supported recent tremendous high quality growth and can be counted on to continue to support continued prosperous growth for many years to come.

Please don't make short term decisions that allow significant and uncontrolled cannabis production that interfere with the magic of Clearview. Most people are unlikely to want to live near places of cannabis growth which has a number of undesirable features that I am sure others have pointed out to you. If cannabis production must be approved, I ask that you introduce appropriate controls and approvals that ensure that it is limited, and does not disturb the fundamental character of area that is so special. The alternative is for people to vote with their feet – this will surely happen where cannabis development is inappropriate to the area.
