## 4.1 Creemore Library Branch Addition Build Project

The Committee raised various considerations that could be added to a checklist for the Library Board to review when preparing renovation plans. Councillor Beelen is going to request further information from Library CEO and Board Chair, Jennifer La Chapelle.

### 5. Two-Minute Fact Share

Jim Campbell shared an article from the Creemore Echo, written by Owen Roberts, about tropicana pulling out of Florida and California. He also shared that the Clearview Sustainability Network is hosting an event called Boulevards, By-laws, Butterflies and Birds on February 6<sup>th</sup> at Station on the Green in Creemore, doors open at 6:30 p.m.

Kim Pickett shared her dismay in learning that many major banks are pulling out of Climate initiatives.

Briar Kelly shared that she learned of an "Experimental Acres" program that Grey County is trying out. The program provides agricultural businesses with \$3000 to try out initiatives that align with the county's greenhouse gas reduction goals.

Allison Fachnie shared that parts of Florida were getting snow.

Councillor Beelen commended Canadian firefighters for providing assistance during the LA fires.

Jerry Sampson shared that he was going on a call later that evening to assist in coordinating resources to send to LA for power restoration purposes. He also shared that the Board of Directors for Devil's Glen Ski Club have decided to no longer use ammonia nitrate to create better race conditions of their hills.
