5.1 Water First Training & Education Inc – Request for Exemption/Reductions of Commercial Development Fees

Executive Director, John Millar provided a brief presentation on Water First's mandate and described the three program areas. He advised they are seeking an exemption/reduction in development charges based on a community benefit as outlined under the Township's Development Charges By-law. This exemption/reduction is for an additional build on Water First's property located on Francis Street in Creemore.

Mayor Measures advised Mr. Millar that staff would need to bring a report back at a future meeting outlining the development charges associated with the proposed build, before Council can make a decision.
