Library programs for children are cancelled when the school buses are cancelled. L. LaFleshe queried whether Library programs should be cancelled on the basis of school bus cancellations. The CEO responded that before this procedure was put in place staff found attendance at programs to be extremely low when buses were cancelled, and that the program ideas and materials are reused. When regular programs are cancelled for this reason, the Deputy CEO ensures that there are independent and child/parent activities in place at each branch. D. Measures noted that the Township of Clearview transit system continues to operate regardless of whether school buses are cancelled or not.
