4.1 Climate Action Awards

5.2 Next Project

The committee considered several potential focus areas, including maximizing green bin use, reducing emissions through community programming, and increasing awareness of farmland preservation. The members selected community preparedness as the next project to support their 2025–2026 goals and priorities.

The committee will undertake a gap analysis to assess current practices and identify opportunities, with support from Briar Kelly, Staff Liaison. It was noted that additional information on the Township's current approach to community preparedness will be needed.

Moved by Jim Campbell, Seconded by Kim Pickett Be it resolved that the Climate Action Advisory Committee select community preparedness as its next project to support the 2025–2026 Goals and Priorities and undertake a gap analysis of community preparedness with assistance from the Staff Liaison. Motion carried.

5.1 Meeting Efficiency and Effectiveness

The committee discussed focusing on its mandate and providing strategic direction. It was noted that the Township has made significant progress on Green House Gas reduction through initiatives such as lighting upgrades and fleet improvements. The Committee will research approaches used by other municipalities and incorporate more informal meetings to brainstorm ideas prior to formal meetings.
