

## **2019 BUDGET APPROVED BY COUNCIL**

Did you know that your residential taxes are divided amongst four key services? Clearview Township (51.5%), Simcoe County (25.4%), Education (14.7%) and Policing (8.5%) \*. Clearview works together with the County, School Board and OPP to provide residents with the public services vital to a safe and thriving rural community.

The 2019 Clearview
Township Budget has been
approved by Clearview
Council. It will support
many key initiatives to
maintain and improve
services and amenities for
the Clearview Township
citizens, while also
investing in infrastructure,
transit and economic
development.

One of the most impactful updates that Council made to the 2019 budget is the addition of \$250,000 for bridge repair reserves.

Most of the bridges in our Township are nearing the end of their useful life and will need replacement soon. Making this investment will ensure

we have the capital to keep road travel safe and accessible.

### HOW ARE YOUR TAX DOLLARS SPENT?

The total municipal budget for 2019 is \$47.2 million dollars. In Clearview Township property taxes are the primary source of revenue used to deliver municipal services. In addition to property taxes, user fees, grants and development charges also contribute to revenue.

In addition to the services that residents expect, the 2019 budget will provide citizens with tangible changes such as road improvements, public transit expansion, completion of the Stayner Library, the first phase of the Station Park redevelopment, park, arena and hall improvements and more.

Approximately \$0.49 of each \$1.00 paid in taxes goes to Clearview. Each tax dollar is divided as shown above.

The 2019 budget includes several major initiatives for citizens. Among those initiatives, four of them can be attributed to approximately 84% of the Clearview Township portion of the tax increase:

- 2.30% or \$334,000 to increase reserves needed for infrastructure repairs and improvements, including \$250,000 for bridge reserves;
- 0.79% or \$114,500 to increase capital funding for Parks and Recreation, including the Stayner Community Centre, a concrete pad in New Lowell, a Duntroon Dog Park, a parking lot for the Nottawa Hall and more;
- 0.61% or \$88,194 to improve Youth Centre Services, and
- 0.41% or \$60,000 to start a Creemore public transit route

Residents will see an estimated net residential tax increase of 2.85% or approximately \$90.36 for the average home assessed at \$293,334.

## FROM THE COUNCILLORS


On December 3rd, 2018 the Inaugural meeting of Clearview Township's 2019-2022 Council was held.


There are many challenges ahead at both County and Clearview Councils and I remain committed to representing all residents of Clearview at both.

During the election, one of the issues I

campaigned on was keeping property tax increases low and manageable. As I write this commentary your Council is in the midst of budget deliberations. I have voiced my concern that a 5% increase in the municipal portion of your taxes is too high. The Province is currently reviewing the structure of Simcoe County and its municipalities. Until we get some clarity as to how this review affects Clearview, I do not think we should be adding to reserves beyond our current annual contributions. Our total reserves presently stand at a healthy \$13,000,000. We also have very little debt. In short, the Township is in good financial shape. Increasing your taxes to add to the reserves at this time would not be prudent in my opinion.

I have also brought a number of your local concerns to Staff with limited success. While I have found this challenging, I will continue to advocate on your behalf.

#### WARD 3 JOHN BRODERICK

Hello Clearview, what an exciting time, so much to consider, so much to balance to ensure the growth and well being of Clearview Township, and the well being of all its residents. The geography of Clearview is vast and contains many


The geography of Clearview is vast and contains many watercourses, as a result, we have 72 bridges and major culverts we are responsible for, with an average lifespan of 75 years, most of these bridges are quickly nearing the end of their safe use and will need replacement.

The new library in Stayner is back on track, with the structural steel on site and being installed and a projected finish in September. Growth appears to be imminent with new model homes in the works. This is Clearview's 25th Anniversary, so watch for celebrations in the spring by going to clearview.ca, and join in the fun. Drive safe. See you around Clearview.


#### WARD 7 JOHN LAMERS

# AGE-FRIENDLY SENIORS HOUSING GRANT PROGRAM



As part of Simcoe County's Positive Aging Strategy, they have launched the 2019 Age-Friendly Seniors Housing Grant Program. The program will award funding to homeowners or developers who complete projects that incorporate accessible, adaptable, and inclusive design modifications for occupants aged 60 and older.

As a Clearview resident, you are eligible to apply for funding. Grants will be awarded to projects that fall into three streams: accessible housing design for seniors, design for individuals with dementia; and the provision of support services for housing that incorporates enhanced aspects of accessibility over and above the building code standards.

# CLEARVIEW OPTS OUT OF CANNABIS RETAIL

On October 17, 2018, under Bill C-45 recreational cannabis became legal Canada wide. The Federal Government set the rules, which allowed each Province to set more restrictive rules. On December 13, 2018, the Government of Ontario amended Ontario Regulation 468/18 which says that at this time 25 retail store licenses will be issued and that no store will be allocated in a municipality with less than 50,000 persons.


Municipal governments had until January 22, 2019, to decide whether they would opt into or out of the retail program. Municipalities that chose to opt out, have the option to opt back in at any time, those that opt-in, however, cannot opt out.

At the January 7th, 2019 Council Meeting Clearview Council followed the recommendation of staff report CAO-009-2019 and opted out of the cannabis Retail Program at this time. Council is taking the time to monitor the effect that opting in has on the community and citizens within the municipalities that have opted in.

Clearview's Strategic Plan includes the development and implementation of policies that focus on small business attraction, development and support. Due to the pioneering nature of retail cannabis, there is no supporting or background research at this time to indicate whether retail cannabis would be an economic driver or detractor for neighbouring businesses. Besides the unknown there are other factors that contributed to Council's decision to opt out:


- With the current provincial framework allowing retail cannabis stores only in municipalities of 50,000 persons or more, Clearview would not be allowed a store.
- Provincial requirements surrounding retail cannabis at the time of this decision were not yet determined.
- The Alcohol & Gaming Commission of Ontario (AGCO) allows a 15-day commenting period for council and the public concerning the location of a retail cannabis store. This is not sufficient time for Clearview to take a report to council and obtain public comments. Since the AGCO decision cannot be appealed, this leaves the municipality without much say as to the location of a cannabis retail store.
- At the current time the province does not permit local municipal official plans, zoning by-laws and licensing bylaws to regulate cannabis retail operations.

Opting out allows Clearview to undertake additional consultation and gain a comprehensive understanding of the Provincial regulations once they have been determined. If the Township then decides to opt back in, a policy for reviewing applications for comment back to the AGCO can be developed, and by-laws can be amended.
