The Water and Sewer rates shall be the rates passed by By-Law by the Council of the Township of Clearview. The Water and Sewer rates are subject to revision and adjustments from time to time.

- 1. The Customer shall commence paying at the authorized rates from the date on which the water meter is installed and the Customer's service is connected to the Water/Sewer systems owned and operated by the Township of Clearview.
- 2. This contract, when executed by the Owner and the Township of Clearview, shall be binding upon them and their heirs, executors, administrators, successors and assigns respectively, and on their property mentioned in this contract and the vacating of said property or change in occupancy or ownership thereof shall not release said property and its owner from this contract except at the option of and with written consent of the Township of Clearview.
- 3. This contract shall not be binding upon the Township of Clearview until executed by the signature of its proper officer, and shall not be modified or affected by any promise, agreement or representation by any agent or employee of the Township of Clearview unless name is in writing and made part of this contract.
- 4. The Customer agrees to provide, free of rental or other charge, convenient and safe space for the water meter, wires and other equipment of the Township of Clearview on or in said premises, and further agrees that no one who is not a properly authorized agent of the Township of Clearview or otherwise lawfully entitled to do so shall be permitted or suffered to repair, remove, inspect or tamper with any said equipment and that the properly authorized agents of the Township of Clearview shall, at all reasonable hours, have to right to read, inspect, repair, replace and remove any of said equipment and have free access for that purpose to said premises.
- 5. All equipment of the Township of Clearview on or in said premises shall be in care and at risk of the Customer. If any said equipment is destroyed or damaged other than by ordinary wear and tear, the Customer shall pay to the Township of Clearview the value of such equipment or the cost or repairing or replacing the same.
- 6. Deposits As a condition of supply of service, the Township of Clearview may require the Customer pay a deposit, the amount of which will be at the sole discretion of the Township of Clearview. The Township of Clearview may waive the said deposit at its discretion; however, it reserves the right to re-implement the deposit, at any time. Failure to maintain the deposit at the level set by the Township of Clearview may result in service disconnection.
