It is the responsibility of the land owner to ensure signage remains visible and is maintained, if the sign is knocked down or damaged contact your local municipal office for replacement.

I/We the undersigned owners of the property subject to the application, acknowledge that approval of a 911 application:

Is to assist in emergency situations only; Does not permit further use or development of the property without the appropriate approvals; Does not constitute the approval of an entrance from a public highway nor does it deem the access safe for use or that it meets and municipal entrance standards; Does not guarantee that access is adequate for emergency vehicles and where access is not adequate, emergency vehicles may not be able to enter the property; Requires the land owner to maintain and keep the access in good repair and ensure the signage remains visible and is maintained. Should the signage be damaged, knocked down or removed the land owner shall contact the Municipality for replacement/repair of the signage.

911 SIGN LOCATION

The property identification (911) sign must be installed at right angles to the road so the numbers are clearly visible to a vehicle approaching from either direction. The sign should be located central to the front of the house/building. There should be a minimum of 30 meters of clear sight distance in either direction from the center point of the traveled portion of the road to the sign.

The property identification sign shall be located not less than 4 meters from the edge of the pavement and not more than 1.0 meter inside the property line. Where there is a sidewalk, the sign shall be located \pm 1.0 meter back from the inside edge of the sidewalk. In rural areas where there are rural mailboxes, the sign may be located above or below the mailbox, if the mail box is located on the same side of the road and immediately adjacent to the property access point.

The mounting height of the sign shall be between 1.0 meters and 1.2 meters above ground level.

Shared Driveways

Where two or more properties share a driveway, signs can be mounted on the same post, however, placement of said signs shall be placed consistent with the descending or ascending property addressing scheme.
