Shannon provided information the on the bi-monthly Activity Kits, there are 50 summer kits available. Shannon also provided an update on the funding received from Second Harvest funding used from March 22 to provide approximately 478 dinners for youth in Clearview all of which were prepared with assistance from Youth at the Centre's kitchen.

March saw 49 youth in March, 55 in April and 65 in May.

The Board discussed sending the Youth Coordinator Report to Council under Communication from the Mayor to promote the Centre and provided updates to Council and the Public.
